A. CALL TO ORDER

FIRST ORDER OF BUSINESS

Roll Call. Public notice of this meeting has been given and a quorum is present.

D. APPROVAL OF MINUTES:

1. Approval of January 04, 2024, Special Call, January 30th, 2024, Special Call, February 20th, 2024, Regular Meeting, and February 26th, 2024, Special Call Meeting minutes.

F. MONTHLY REPORTS OR UPDATES:

1. Utility Department

a) Monthly report: Craig McCollum gave an update on the utility department and report from Glenn Trimble. We have gotten bids for the pavilion for the park with the best bid being \$8307.00 including labor, material, and cover for well 5. The pavilion currently will not have electricity but maybe in the future. Started repairs on the gas line this week, \$27,900 for 1025 ft plus fix two more leaks at \$270 per hour.

2. Park/City Beautification

Updated by Alderman Dee Roden. Baby swing to be ordered that was paid for through donations from the Women of Winona group.

3. Mayor Updates

a) Update on permits submitted for processing. No permits have need applied for nor approved.

b) Update on Lawsuit.

Attorney Blake Armstong explained to the council that the law firm originally hired discovered a conflict of interest in this case. We have found a new law firm, Jackie Carr with Wilson Firm in Tyler, who will be reaching out to the mayor to set up a meeting. After that we will receive a letter of intent to work with the new firm on the lawsuit.

G. DISCUSSION AND ACTION ITEMS:

 Discussion and possible action to accept the City Secretary's certification of unopposed candidates and adopt the order of cancellation. Alderman Laney Barnes made the motion to accept the certification of unopposed

candidates and adopt the order of cancellation and seconded by Alderman Craig Attaway. All in favor; none opposed. Motion carried unanimously.

 Discussion and possible action to join Tyler Economic Development Council (TEDC). Mayor Pro-Tem Dee Roden made the motion to join TEDC at the \$5000 per year tier and seconded by Alderman Laney Barnes.

All in favor; none opposed. Motion carried unanimously.

3. Discussion and possible action to do a new rate increase for industrial park and projects on gas system that need gas line extension or upgrades.

Mayor Pro-Tem Dee Roden made the motion to approve a new rate structure of \$11.00 + cost for the industrial park and new gas projects connecting to the system that need gas line extensions or upgrades to the lines and seconded by Alderman Laney Barnes. All in favor; none opposed. Motion carried unanimously.
