Alderman Gary Fox made the motion to table until next meeting and seconded by Alderman Laney Barnes.

All in favor; none opposed. Motion carried unanimously.

10. Discussion and possible action to adopt the Ordinance for the new gas rates.

Alderman Laney Barnes made the motion to accept the Ordinance and seconded by Mayor Pro-Tem Dee Roden.

All in favor; none opposed. Motion carried unanimously.

11. Discussion and possible action to consider rate increases for the water, sewer, and gas.

Mayor Pro-Tem Dee Roden made the motion to increase the gas rates by \$0.50 on the base rate and increase the city cost up by \$0.0005 per cf (\$0.50 per Mcf), increase the water and sewer rates by \$0.25 to the base each and \$0.00025 per gallon (\$0.25 per 1000 gallons) to be effective on the July billing and seconded by Alderman Craig Attaway.

Three (3) in favor; one (1) opposed. Motion carried majority vote.

12. Discussion and possible action to consider rate structure change for commercial deposits.

Alderman Laney Barnes made the motion to table until next meeting and seconded by Mayor Pro-Tem Dee Roden.

All in favor; none opposed. Motion carried unanimously.

13. Discussion and possible action to approve a new phone and tablet purchase for the mayor.

Alderman Gary Fox made the motion to approve the mayor to get a new phone and tablet and seconded by Mayor Pro-Tem Dee Roden.

All in favor; none opposed. Motion carried unanimously.

14. Discussion and possible action to open another bank account for the funds not covered by the FDIC.

Mayor Pro-Tem Dee Roden made the motion to give the mayor the permission to gather further information and bring back to the council for approval and seconded by Alderman Garv Fox.

15. Discussion and possible action to hire a part-time worker in the utility department.

Mayor Pro-Tem Dee Roden made the motion to hire one full-time worker and one part-time worker and seconded by Alderman Craig Attaway.
